Starting August 2017 a \$25 Refundable Deposit is Required before Drill can be removed from the District property. Deposit will be refunded if, and only if, the drill returns to the District **clean, free of seed and dirt.**

<p>PAYMENTS:</p> <p>*INSURANCE:</p>	<p>A deposit of \$25 is required before services begin or at the time the contract is signed. Use is scheduled in increments of three (3) day consecutive periods. A \$50.00 per day fee will be assessed for any time that exceeds three (3) days, unless <i>previously</i> arranged with the administrator. Balance is due within 30 days after services are rendered. A 1.5% finance charge is added to all accounts that are past due after 30 days.</p> <p>The landowner hereby represents that he DOES have in force a valid liability insurance policy with _____ Insurance Company and agrees to hold Newaygo Conservation District harmless as to any liability which may arise out of the landowner's transportation and/or use of the no-till drill.</p>

USE REQUIREMENTS

<p>TRAVELING:</p> <p>AFTER USE:</p> <p>DAMAGE:</p>	<p>SPEED LIMIT WHEN PULLING THE DRILL IS NOT TO EXCEED 25 MPH.</p> <p>After using the drill, you must spray all parts of the drill off with a water hose to eliminate any soils remaining on the discs or any other parts of the drill. It is YOUR responsibility to remove any unused seed from hopper and tubes. Drills returned dirty will result in the District keeping the \$25 deposit.</p> <p>Please notify the administrator immediately of any damages that occur or any parts not operating correctly. A fee may be applicable.</p>
